

Pooches & Parasols on Parade Rules and Waiver

All animal owners must follow all posted pet parade rules. Please remember, dogs must meet all guidelines and maintain current. Please sign and return with your check payable to Pilot Club of Crystal River.

Pet Rules:

- All animal parade walkers must pre-register by mail. You will receive your entry number the morning of the parade, between 8am & 8:45am. A waiver must be signed for each animal entry & mailed with payment to Pilot Club of Crystal River, P.O. Box 1971, Crystal River, FL 34423.
- Children accompanying pets owners must be strictly supervised and at least 12 years of age to walk a pet in the parade. Your pet must be in costume to participate.
- Children under the age of 12 can walk in the parade with a stuffed animal but it must be in costume.
- All animals must have a recent shot record and up to date with all vaccinations current.
- All pets must remain on a leash at all times and all owners must remain with their pet. They can be in strollers, wagons or Golf Cart.
- If you are using a stroller, wagons or Golf Cart for the parade these items must also be decorated for Easter as well, if not they cannot be used in the parade.
- Aggressive dogs and female dogs in heat are not allowed. Owners must immediately leash and remove dogs from the event at the first sign of aggressive behavior.
- Please be courteous to others and remove any sick pets from the pet event.
- Owners must dispose of waste properly in the designated on-site containers.
- While small bite-sized training treats are permitted, bowls of water must be in plastic containers NO GLASSWARE will be permitted.
- Pets must be licensed and current vaccinations. Current license and rabies tags must be worn on the pets collar at all times.

- Florida State Law requires all dog bites to be reported to ACO. In addition, owners are required to assist in the investigation of incidents of aggression or biting by providing appropriate identification and information to ACO, AND to other dog owners who are involved with the incident under investigation.
- Owners are liable for any injury or damage caused by their pet and are fully responsible for their pets actions.

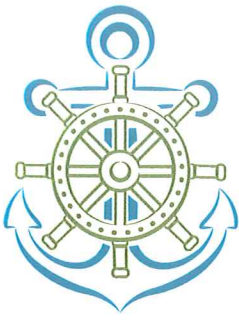
