

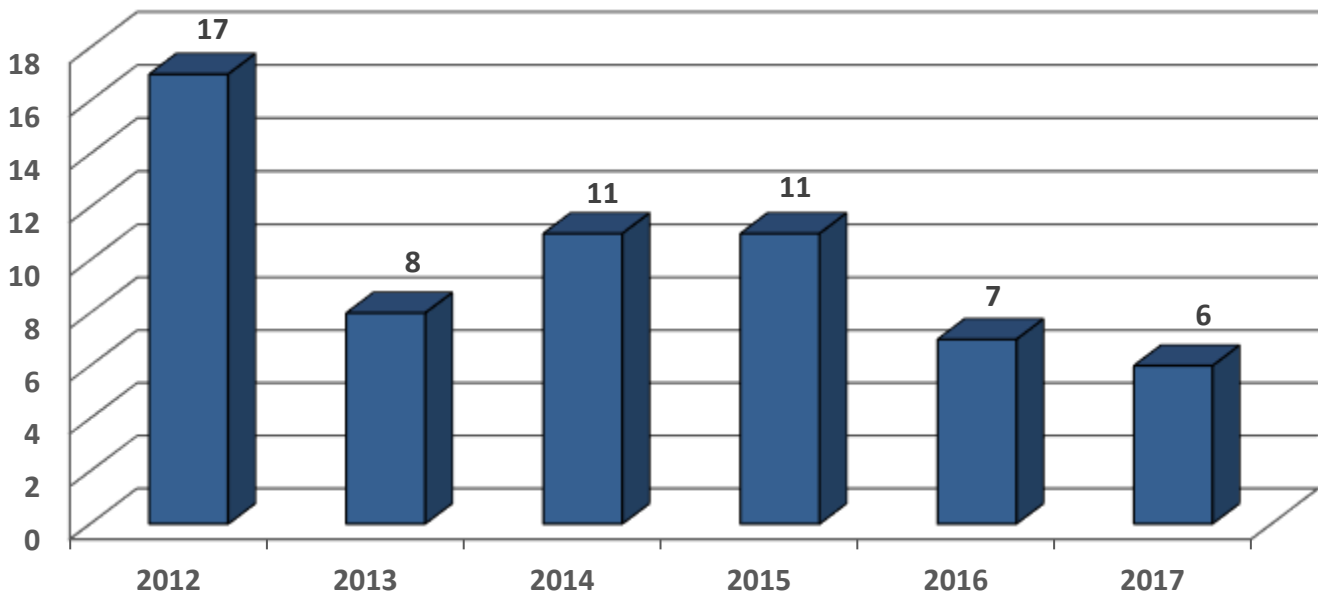

City of Crystal River Combined tracked Crime - 1st Quarter 2017

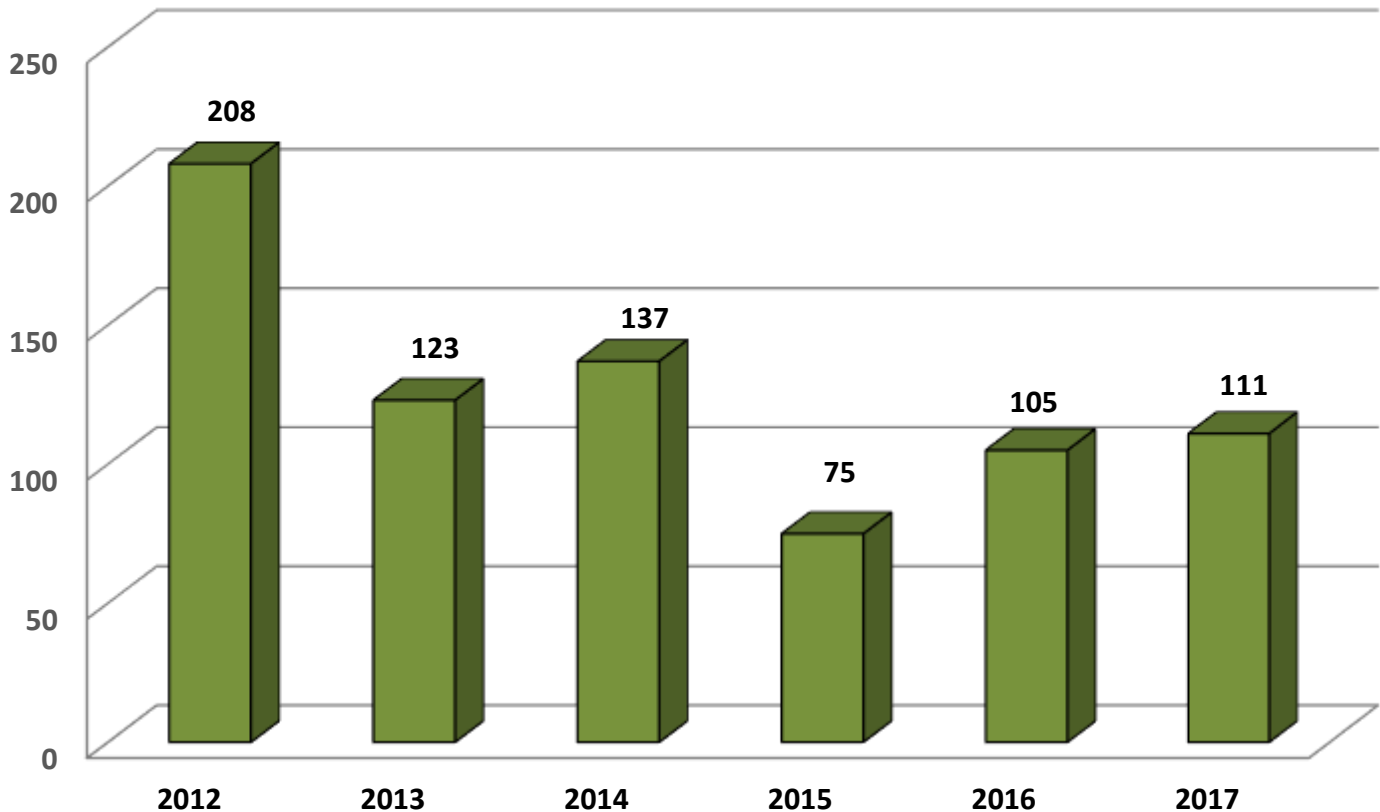

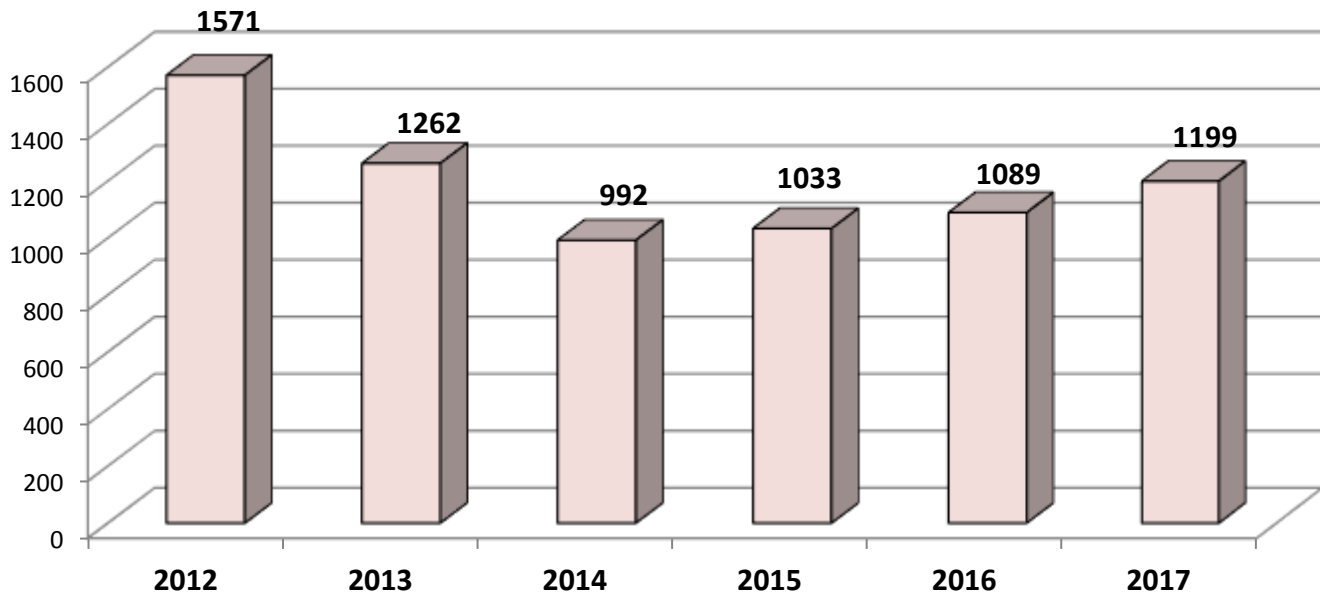

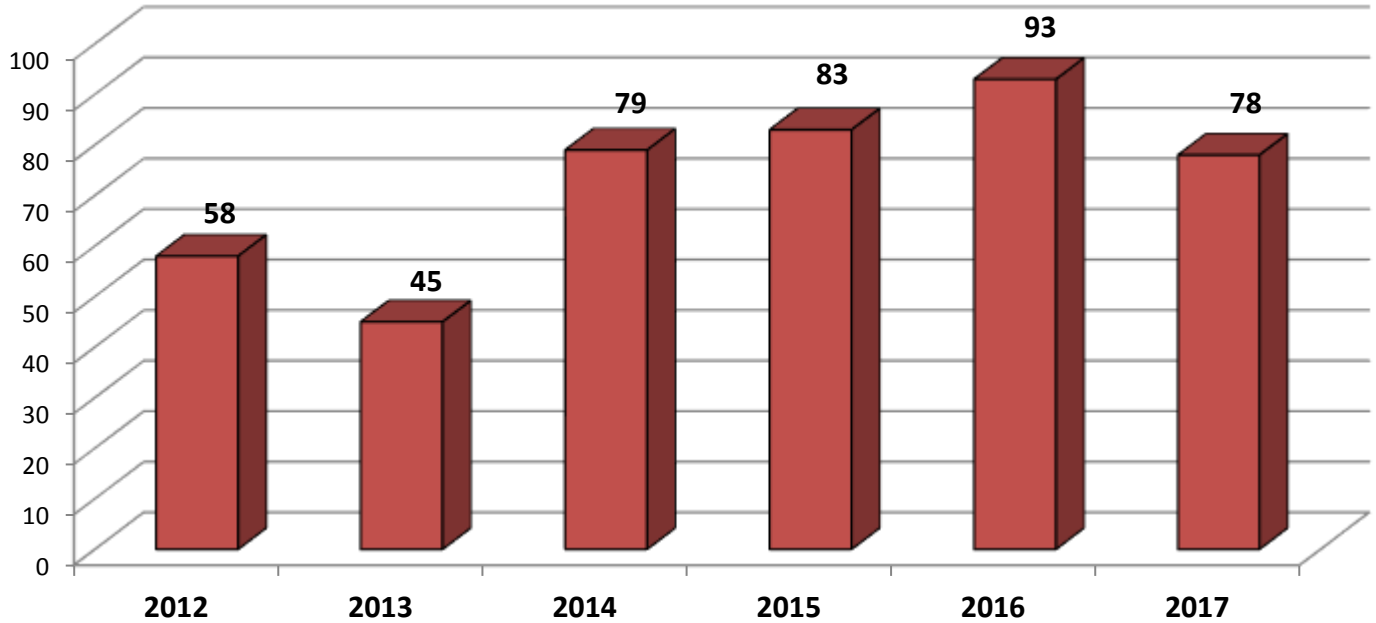
City of Crystal River Warnings and Citations - 1st Quarter



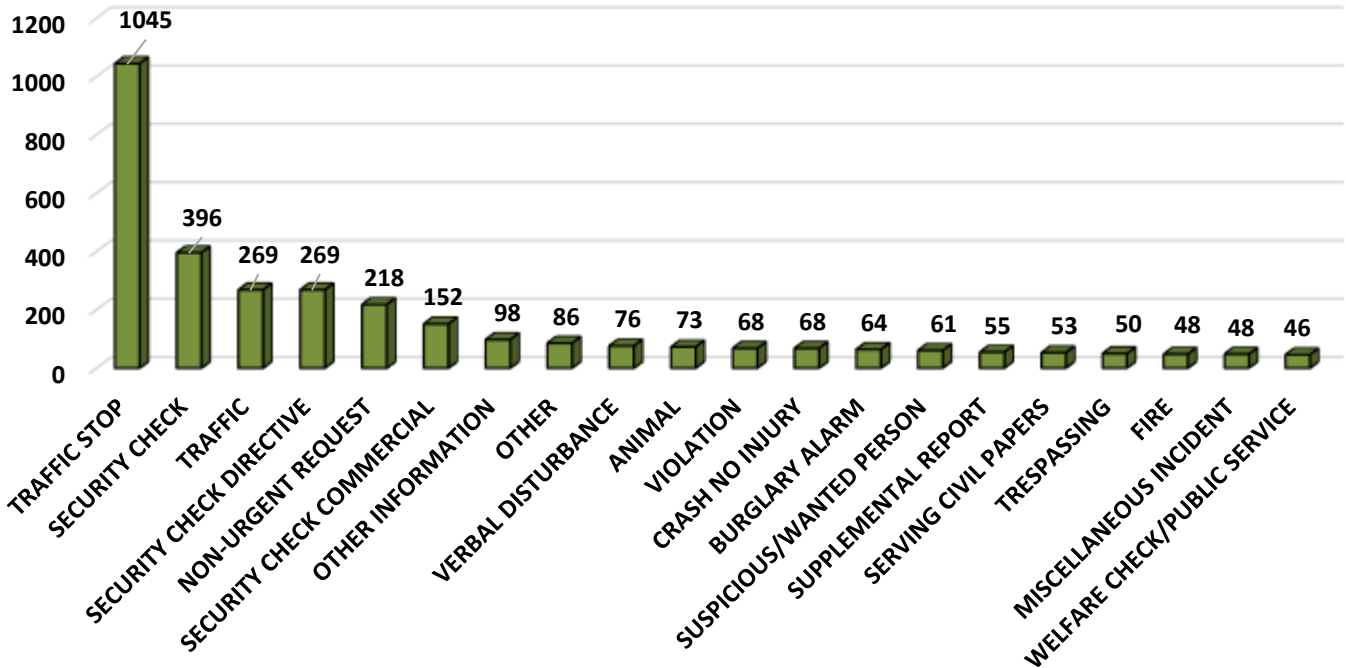
