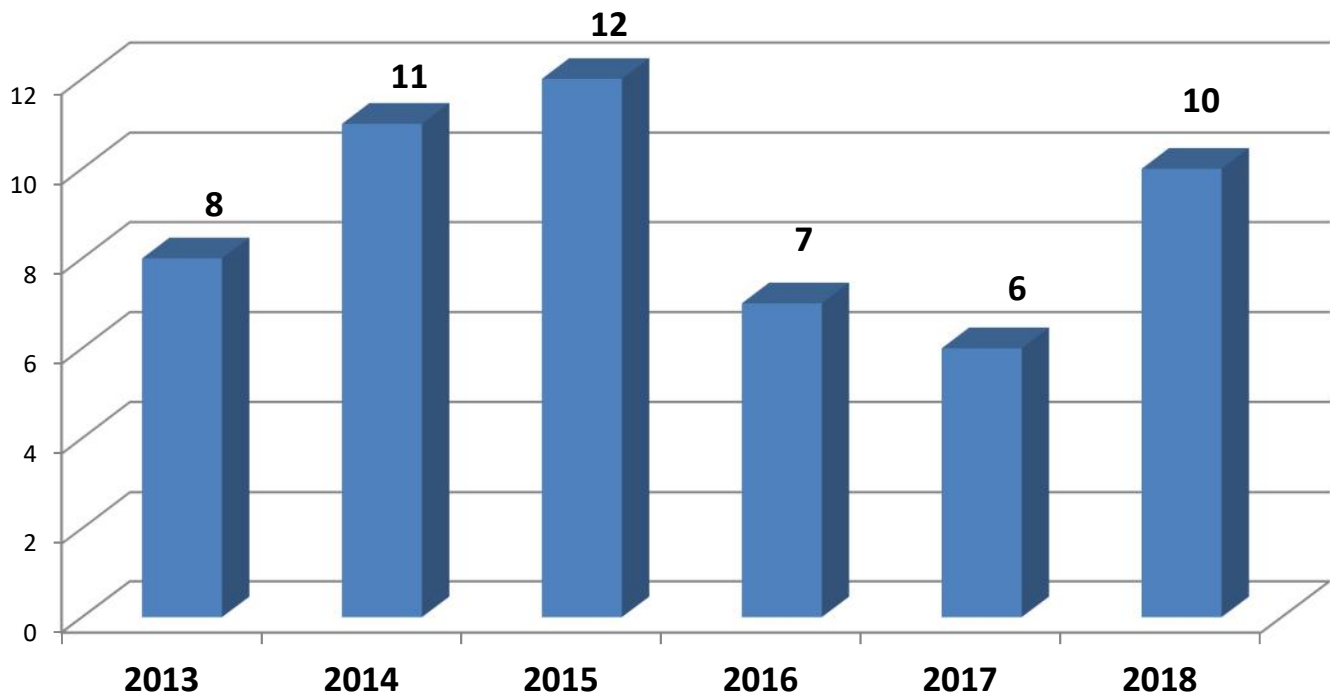

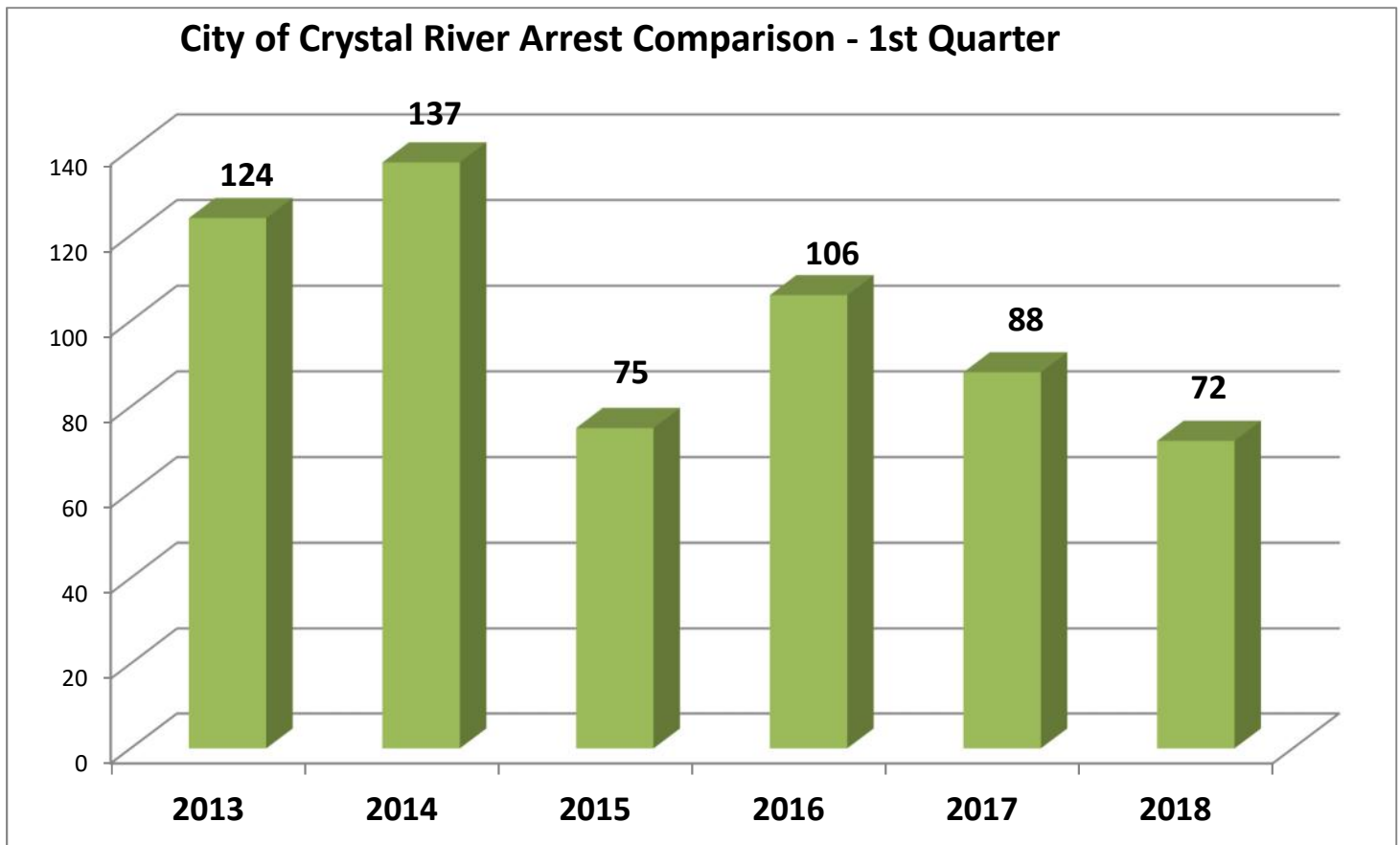
#### City of Crystal River Combined Tracked Crime - 1st Quarter 2018

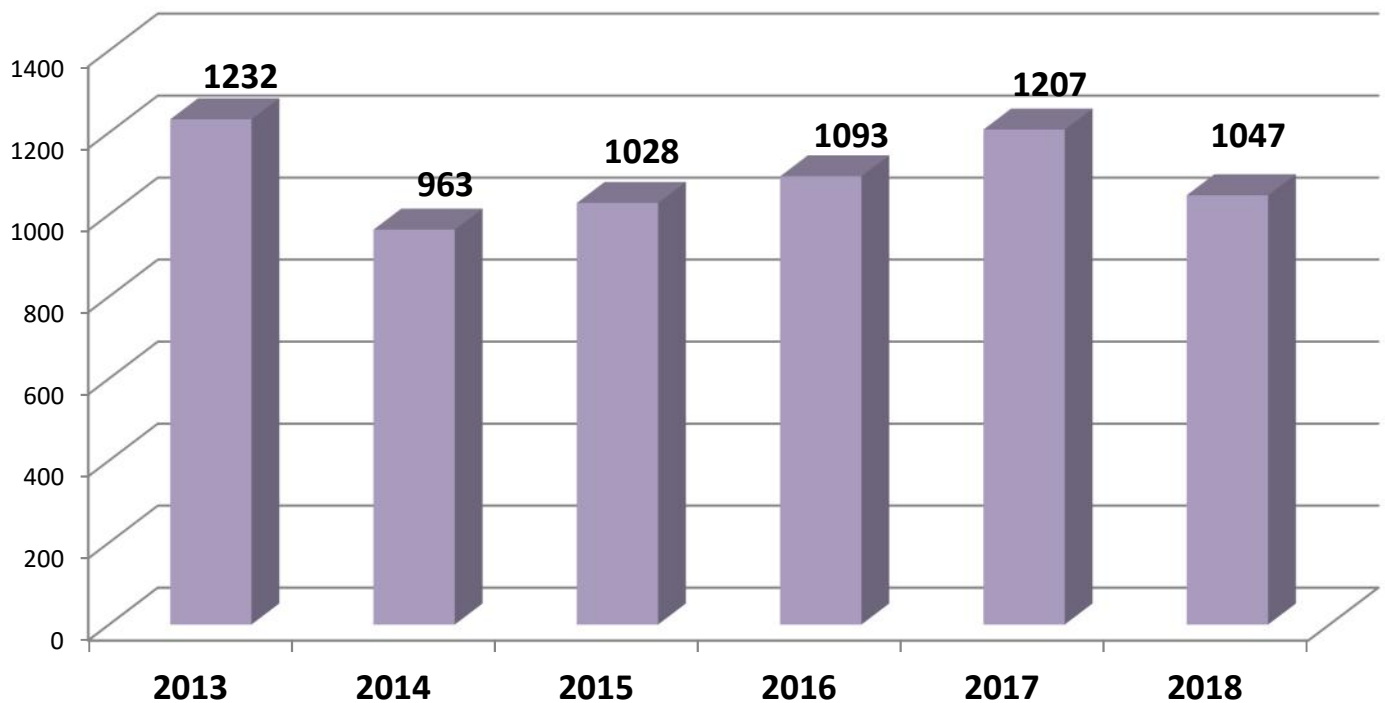

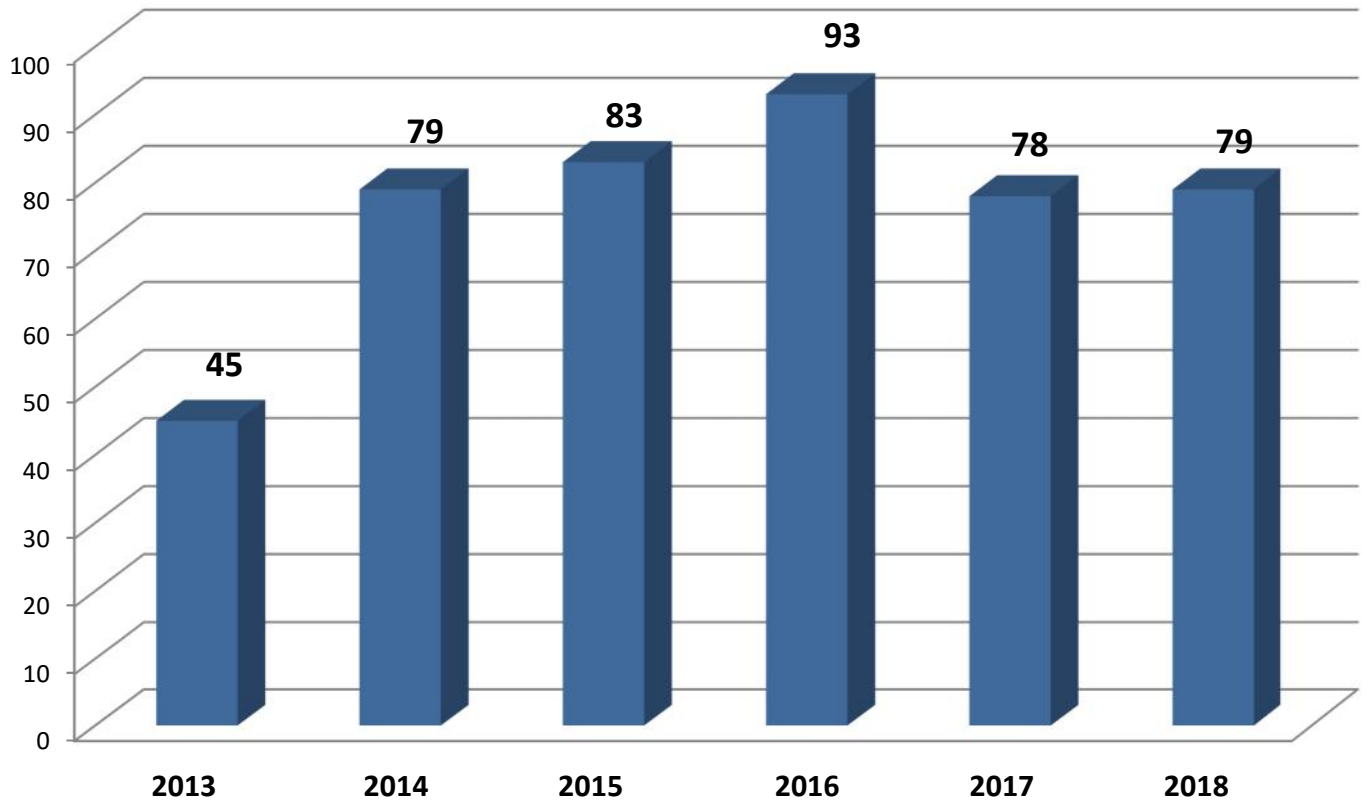
### City of Crystal River Warnings & Citations - 1st Quarter



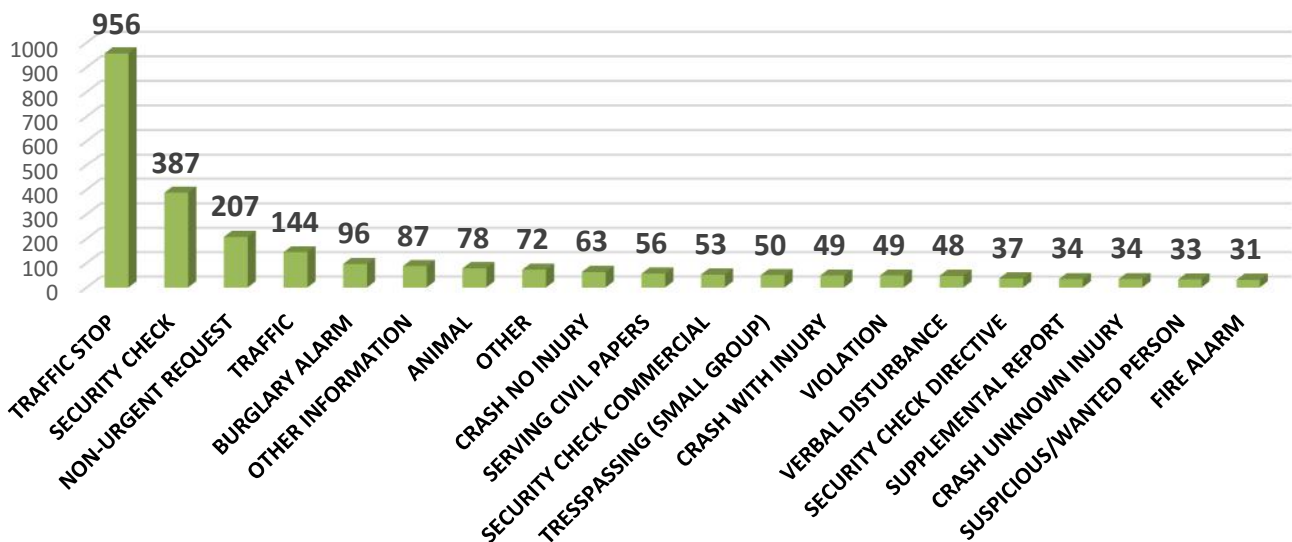
